Events and Activities



The EMAS **Annual General Meeting (AGM)** was held on 11 October 2024 at Devan Nair Institute; and attended by 37 member companies, Observers, EMAS 2nd Advisor, the National Environment Agency (NEA) and Enterprise Singapore (ESG).

Employment and Employability Institute (e2i) shared information on supporting industry transformation with services like placements, recruitment, training funding, and professional development. The presentation extended an invitation to apply for the CTC grant, with success stories as examples.

SkillsFuture Singapore (SSG) introduced the SkillsFuture Level-Up programme, offering tailored workshops to promote lifelong learning, boost productivity and keep staff competitive.

EMAS provided an update on our Local Enterprise and Association Development (LEAD) Program. The EMAS Constitution will be revamped to reflect updated practices and future plans of EMAS. The votes were witnessed by ESG and NEA representatives. The Constitution changes will be lodged with the Registrar of Society (ROS).



EMAS and WMRAS jointly organised our inaugural **EMAS & WMRAS Golf and Members Day 2024** at the **Orchid Country Club** on 24 October 2024. Together, the associations employ a workforce of 72,000 individuals who play a key role in maintaining Singapore's cleanliness.



The day began with a golf challenge featuring 29 flights, where senior management from cleaning companies enjoyed a friendly competition on the greens.

In the afternoon, cleaning staff brought energy and excitement to the event as strikes and spares lit up the 15 bowling lanes, fostering an atmosphere of camaraderie and joy.



The event received strong support with 8 Eagle sponsors. Event sponsors included Cycle & Carriage Industries and IWC Schaffhausen as 2 Hole-in-One prizes.









The evening dinner gathered over 330 industry professionals. EMAS' Guest-of-Honour was Minister Grace Fu, Ministry of Sustainability and the Environment (MSE).

Dialogues, Briefings and Engagements



On 17 September 2024, EMAS met with our lead agency partner, **National Environment Agency (NEA)** Director, Mr. Halmie Mattar and the NEA team to discuss pressing local labour challenges.

This productive session focused on fostering stronger partnerships and identifying opportunities to drive growth and benefit the cleaning industry.





In a series of **NEA-led closed-door dialogues** held on 20 Aug, 21 Aug and 28 Aug, 33 representatives from 25 NEA-licensed cleaning companies shared valuable feedback and observations regarding the current situation faced in Integrated Facilities Management (IFM) tenders within the cleaning sector. These collaborative discussions highlighted critical concerns and explored potential best practices to navigate the evolving landscape effectively.



A comprehensive findings report, summarising these insights, was submitted to NEA and Enterprise Singapore (ESG) to advocate for meaningful improvements in industry processes.

EMAS met with the **Building and Construction Authority (BCA)** on 16 October. At BCA's request, all reports and findings were shared so as to provide practical recommendations, further supporting industry advancements. Stay tuned for updates!

Skills Development and Training

The SkillsFuture Career Transition Programme (SCTP) is a joint effort by Temasek Polytechnic (TP), the Environmental Management Association of Singapore (EMAS) and the National Environment Agency (NEA).

From April 2025, mid-career workers looking to acquire skills needed in the environmental services sector will be able to take up a course at TP and use their SkillsFuture credits to offset the fee.

The full-time, three-month course is the first such initiative for the industry, and will cover topics including robotics, automation, and outcome-based contracting for cleaning services.

Outcome Based Contracting (OBC) for Cleaning Services
