


[Applications Open] Get Recognised as a Company of Good

Clean & Green Singapore (CGS) 2025, led by the NEA, was a year-long national movement involving many activities and culminating in CGS Day on 1 November 2025, at Our Tampines Hub. CGS focusses on public hygiene, environmental care,

waste reduction (like the "Say YES to Waste Less" campaign), and encouraging sustainable habits through school programs, community events, and vouchers for green appliances.



The **Tripartite Alliance Award (TAA) 2025**, was held at Shangri-La Singapore, 14 November 2025. EMAS was represented by Sharon Kee and Faith Wong (Honorary Secretary and Assistant Honorary Secretary respectively).



The award ceremony celebrates exemplary employers and their commitment to advancing fair and progressive practices. The event is organised by **Tripartite Alliance for Fair and Progressive Employment Practices (TAFEP)**.



As partners in this transformative journey of Environmental Services, EMAS shared inputs on **Singapore International Facility Management Association (SIFMA)**'s Outcome-Based Contracting (OBC) Playbook; referencing NEA's OBC Guide version 2 for cleaning requirements. The Playbook was launched on 25 November 2025. EMAS continues to work closely with NEA, providing industry insights and feedback to support the development of the OBC Guide.

Dialogues, Briefings and Engagements

An engagement meeting was held on 18 December 2025 with EMAS to discuss the next bound of Progressive Wage Model (PWM) wages for the industry.

EXCO Meeting (Salient Points)



EMAS is proposing updated membership criteria for both Professional and Student Members. Professional applicants must be Singaporean or Permanent Resident, with relevant work experience or environmental-related qualifications, and submit their CV and NRIC. Student membership will be open to eligible students aged 18 and above, with verification measures and enhanced benefits such as exposure, networking, and internship opportunities.

For PR & Communications, a data-driven or research role remains vacant and will be filled on an as-needed basis by an EXCO representative to lead. For Technology, Innovation & Digitalisation, one position is currently vacant and will be reviewed with EXCO when required. For Constitution Sub-Committee, EXCO has agreed that this sub-committee is not required at this time and will be dissolved.

In other updates, Waste Management and Recycling Association of Singapore (WMRAS) will advise if they would like to continue their participation for Members Day 2026 after their EXCO meeting in January 2026.

EMAS Annual General Meeting (AGM) 2026 will be held on 16 October 2026 at Temasek Polytechnic.

CESG Catalyst 2026 is scheduled for 6 June 2026 at Marina Bay Sands. EMAS has been invited to organise a one-hour session during the afternoon segment.



A list of 29 EMAS members providing deep cleaning services was published on the EMAS website in November 2025. An additional 2 cleaning companies have been added with a total of 31 members included in the list for “[Deep Cleaning Coffeeshop Toilets](#)”.



Nicole Poh has stepped down as EMAS Legal Advisor due to other professional engagements. Her last day with EMAS was 31 December 2025.



EXCO is reviewing a proposed redesign of the EMAS logo to improve visibility of the association's name. Legal consultation has been completed, and a design rationale will be developed to guide logo usage. Estimated redesign costs were shared; with some EXCO members checking alternative quotations. A simple usage agreement will also be introduced for members who wish to use the EMAS logo.

For Health Custodian and Lead Custodian training, proposed course durations of 14.5 and 13.5 hours from agencies were reviewed. EXCO opined to reduce both courses to 8 hours (inclusive of assessment) for consideration.

Skills Development and Training



ETIH@TP Course on ***Outcome Based Contracting (OBC) for Cleaning Services: Effective Implementation with Digitalisation and Automation*** [TP-NC-E0046-F] was held on 12 and 13 November 2025.

Referencing Singapore Standard 694:2023 and a successful eco-campus case study, the course equipped participants with practical knowledge on OBC contract clauses, cleaning outcome benchmarks, and service buyer-provider partnerships.

Participants also learnt to use performance inspection tools, apply digitalisation, robotics, automation and IoT, and received hands-on guidance in drafting OBC contracts and conducting inspections with industry practitioners.

EMAS, in partnership with Temasek Polytechnic and Yellow Ribbon Singapore, delivered the industry's first 300-hour SCTP Environmental Services programme to support ex-offenders' reintegration.

The programme provides industry-relevant skills, nationally recognised certifications and clear pathways to employment, advancing a more inclusive and supportive society.
